*Vaccinations can be provided by LMP under certain circumstances. However, we prefer they be administered 24 hours in advance of boarding, as you may notice side effects or changes in behavior that we may think are normal. We require Parvo, Distemper and Bordatella. The Parvo/Distemper and the Bordatella vaccine are separate vaccines and are a charge of \$25.00 per pet- per vaccine. We cannot administer the Rabies vaccine.

We provide Mid-Grade dog food as it is easier on digestion. If this is unacceptable or another food is preferred, It will be provided by the Parent. Any medications will also be the sole responsibility of the pet parent.

*****Please Note*****

We do offer grooming services that can be performed during your stay, but some services may be deemed required while staying with us. For example, if your pet has fleas or ticks, we are required to get rid of them upon drop off to ensure no other animal contracts them. If your dog is severely matted or requires other grooming needs that are deemed required, we will perform those services and apply the cost to your bill.

Emergency:

The utmost care is given to each pet staying with us, and we love each one as our own. Unfortunately, things can happen that are beyond our control. If your pet develops a medical condition or if an emergency does arise requiring veterinary care for Pet, care will be provided by Bienville Animal Medical Center. LMP will notify Owner of the emergency as soon as reasonably possible (with deference given to the urgency required for treatment of Pet) at the contact info provided.

It will be the responsibility of the parent to pay any costs incurred whether for damages to facility or punitive damages.

Please make sure that all statements are true, this greatly affects the care that your pet receives as well as the comfort and happiness of all pets in the facility.

There shall be no liability for acts of nature, ingestion of foreign objects, insect infestation or bites, contact with wildlife, lightening or other Acts of God.
